Untreated solid wood (A I), such as e.g. pallets, cable drums, squared timber, vegetable boxes, cuttings and chips, belongs in the **wood container** for untreated waste wood.



**Untreated solid wood (A I), such as e.g.**

- (Euro) pallets made of solid wood
- Cable drums (manufactured after 1989)
- Squared timber
- Furniture, kitchens and other interior fittings made of solid wood
- Fruit, vegetable and transport boxes made of solid wood
- Cuttings and chips

- Waste wood with residues of roofing felt, carpet or floor covering
- Railway sleepers
- Mineral bonded wood wool boards,
- Upholstered furniture and bulky waste
- Trunk wood, root wood and limb wood

**Note:** Nails, screws and small hinges do not need to be removed.

Laminated or painted waste wood (A II) and coated waste wood (A III), such as beams, floorboards, doors, laminate flooring, OSB and chipboard, belong in the **wood container** for treated waste wood.



**Laminated or painted waste wood (A II), e.g.**

- Beams and building timber
- Boards, faulty floors, board formwork from interior construction
- Pallets made of wood-based materials
- Roof boards
- Transport boxes made of wood-based materials
- Doors and frames of internal doors (without harmful contamination)

**Waste wood coated with, for example, paints, varnishes, adhesives or flame retardants without glazes or pesticides (A III), such as e.g.**

- Wood waste from bulky waste
- Laminate flooring
- Furniture, kitchens and other interior fittings
- OSB boards
- Chipboard

- Waste wood with residues of roofing felt, carpet or floor covering
- Railway sleepers
- Mineral bonded wood wool boards,
- Upholstered furniture and bulky waste
- Trunk wood, root wood and limb wood

**Note:** Nails, screws and small hinges do not need to be removed.

The **wood container** for wood waste containing dangerous substances such as glazes or pesticides (A IV) is for e.g. wood contaminated with harmful substances and wood used outdoors.



- Sections, wood, chipboard and veneers
- with harmful impurities
- Construction and demolition waste wood with harmful impurities
- Firewood
- Insulating and sound-proofing panels treated with agents containing PCBs
- Wood used in windows (without glass)
- Woods from use in agriculture, water engineering, industrial application and mining
- Timber framework and rafters
- Impregnated wood from outside such as garden furniture, decking boards
- Lattice fence
- Cable drums made of solid wood (manufactured before 1989)
- Construction timber for load-bearing parts
- Telegraph/telephone poles
- Ammunition boxes
- Outside doors, door leaves (painted)
